



# Q1 What is your home county in Ohio?







## Q2 Were you able to schedule an appointment?



### Q3 What is the wait time for an appointment to renew your CHL?



### Q4 Did you schedule the appointment in your home county or an adjacent county?



### Q5 Will your CHL expire before you can renew?


